BEHAVIORAL HEALTH CRISIS STABILIZATION UNIT

Glens Falls Hospital is the only behavioral health inpatient facility in Warren and Washington Counties, and it serves only adults over the age of 18. Inpatient beds for children and adolescents require special licensing and staffing and are unfortunately in very short supply across New York State.

To support the behavioral health services within the Emergency Department, Glens Falls Hospital has a Crisis Stabilization Unit (CSU) for behavioral health patients seeking treatment. This allows them to have an appropriate setting for treatment until they can be admitted, discharged from the Emergency Department, or transferred to another organization. The unit has 7 patient rooms, used by adults and children alike who are seeking treatment, and a small common area.

Isolation and lack of access to mental health resources during COVID-19 led to an explosion of patients experiencing mental health crises. Many times, these patients end up visiting their local emergency department while awaiting inpatient services. At the same time, a shortage of behavioral health inpatient beds throughout New York State has led to longer wait times for placements.

Since the start of the pandemic, the GFH CSU has been routinely over capacity with adults, children, and adolescents. When the CSU is full, due to the lack of inpatient beds, behavioral health patients must remain in the same area as patients with medical emergencies within the emergency department. This causes a serious strain on our current CSU and medical emergency room.

In 2022, we had adolescent patients who had particularly long stays in our CSU. One was there for 84 days, another for 99 days, and yet another for 117 days before an

appropriate placement for care could be secured. The CSU was intended only for brief stays measured in hours in a locked and safe environment pending admission or transfer, but unfortunately recently we have seen stays measured in days, weeks, and months for some of our youngest and most vulnerable patients. Imagine 117 days in a windowless room in the emergency department under 24/7 observation!

Due to this crisis, our behavioral health team devised a plan to repurpose an area of our inpatient behavioral health unit and reconfigure it into a new 15-room CSU with two sections in a way that children and adolescents will be segregated from adults. Patient bedrooms in the new CSU will be larger, and many will have a window. The new unit will also accommodate larger common areas where staff can engage the patients with group therapy as well as entertainment opportunities.

The cost of this project is \$2,434,752, a huge sum when all hospitals are facing financially challenging times. Glens Falls Hospital was able to secure \$1,190,000 toward this project from the American Rescue Plan Act funds distributed through Warren County, and our generous community donated an additional \$1,521,890 to the relocation and expansion of the Emergency Department's Crisis Stabilization Unit, more than covering the projected cost of the plan. Construction is slated to begin before the end of 2023.

THE SHERIDAN CONNECTION

In 1994, catheter industry entrepreneur **David Sheridan** and his wife **Janet** made the lead gift of \$1,000,000 to Glens Falls Hospital toward the construction of a new **David S. and Janet R. Sheridan Emergency Care Center at Glens Falls Hospital** for our community. Through the foundation established by Mr. and Mrs. Sheridan, the Sheridan family has remained

committed to our hospital, donating to many important projects over the years, including the Greenwich Medical Center, the Surgery Center, a linear accelerator for the C. R. Wood Cancer Center, and the special care nursery in the Joyce Stock Snuggery. For **Davene Brown**, the Sheridan's daughter and president of the David S. and Janet R. Sheridan Foundation, making a \$500,000 contribution in support of the Emergency Department's relocation and expansion of the Crisis Stabilization Unit was a natural fit.
