

# THE SHERIDAN FAMILY: A LEGACY OF COMMUNITY SUPPORT



From its very beginnings in 1897, Glens Falls Hospital has relied on the outstanding generosity of the Glens Falls community. Over the past 127 years, that community support has enabled the hospital to grow by expanding its buildings, acquiring the latest medical equipment, and developing new service lines in its mission to provide outstanding healthcare to the 6,000 square mile region it serves today.

One of the most significant examples of that generosity occurred in 1994 when **David S. and Janet R. Sheridan** pledged **\$1,000,000** to establish the emergency department that bears their names to this day. At the time it was the largest individual gift Glens Falls Hospital had ever received. The David S. and Janet R. Sheridan Emergency Care Center opened in 1998, transforming the way emergency medicine was provided in our region.



Their gift of such transformational magnitude was very much in character for this couple that was deeply committed to advancing healthcare generally with a focus on the health and wellbeing of the community in which they raised their family and built their business.

The son of immigrants and raised in Brooklyn, NY, **David Sheridan** was a classic American success story. He used \$35,000 that he'd earned from his family's hardwood flooring business to launch a medical equipment manufacturing company in 1939, United States Catheter and Instrument Corp (USCI). He then invented the disposable plastic catheter, a revolution that eliminated the need to sterilize and reuse rubber catheters. This life saving innovation reduced the spread of diseases and infections.

United States Catheter and Instrument Corp was the first of four catheter companies he was to start and later sell over the course of his lifetime, the others were Sheridan Catheter and Instrument Corp. (sold to Sherwood Medical), National Catheter Corp. (sold to Mallinckrodt Anesthesia Products), and Sheridan Catheter Corp. (sold to Tyco Health Care). Sheridan held over 50 medical device patents and he received numerous recognitions for his innovations from professional organizations including the American Society of Anesthesiology and the Society of Plastics Engineers.

In 1987, he received an honorary doctorate in science from Albany Medical Center. He was so successful in the industry that Forbes Magazine nicknamed him the "Catheter King" in 1988. His national prominence was evidenced by the fact that his obituary ran across the nation including in The New York Times, The Washington Post, and the Los Angeles Times.



Sheridan's companies employed thousands of workers in Washington and Warren Counties, making our region the catheter capital of the world.

**Janet R. Sheridan** was born in Saskatchewan, Canada and moved with her family to Washington County, NY as a child. She graduated from Greenwich High School. Janet met David Sheridan in Glens Falls and they married in 1945. They settled down on a farm in Argyle where Janet devoted her time to raising their four children, (Ross, Davene, Hollis, and Pamela) and supporting her husband's business enterprises.

The Sheridans didn't just leave an indelible mark on the medical equipment industry, they left a substantial philanthropic legacy as well. During their lifetimes they made transformative gifts of **\$1,000,000** to Albany Medical College to establish the David S. Sheridan and Dr. Ralph D. Alley Endowed Chair in Cardiac Thoracic Surgery, underwrote the cost of building Albany Medical Center's magnetic resonance imaging center, and endowed a chair at Harvard Medical College. The National Society for Fundraising Executives (NSFRE) recognized David Sheridan with their Outstanding Philanthropist Award in 1995.

The Sheridans created The David S. and Janet R. Sheridan Foundation to secure their philanthropy for the future. The Foundation continues to support Glens Falls Hospital generously, along with over three dozen other nonprofit organizations each year, most of them located in Washington and Warren counties.

Davene Sheridan Brown, the foundation chair, says, "Our family is honored to keep our parents' legacy by continuing to improve the healthcare in our area."

# CRISIS STABILIZATION UNIT UPDATE

The COVID-19 pandemic has had a monumental impact on all aspects of healthcare locally and globally and Glens Falls Hospital is adapting to some new realities. Our community hospital is home to the busiest emergency department in northeastern New York, with over 40,000 patient visits each year. Since March 2020 we have witnessed an explosion of mental health crises. This increase has disproportionately impacted youth.

The Sheridan Emergency Department has a Crisis Stabilization Unit (CSU) with seven beds to care for patients experiencing a mental health crisis. That unit experienced a 207% increase in its average daily census during the first year of the pandemic, and nearly 30% of those patients were adolescents or children. The unit is intended to stabilize patients and provide a temporary safe space for them until they can be discharged safely or admitted to a treatment facility. Compounding the influx in patients is the limited number of mental health inpatient beds and supportive living environments in New

York for children and adolescents. As a result, some young patients had long stays in our short-term stabilization unit. One adolescent was there for 84 days, another for 99 days, and yet another for 117 days before an appropriate placement for care could be secured.

The need to relocate and expand the CSU became urgent by 2022. Thanks to generous community philanthropy, which raised **\$1,521,890**, including a **\$500,000** gift from The David S. and Janet R. Sheridan Foundation, and a Federal grant of **\$1,190,000** from American Rescue Plan Act (ARPA) funds administered by Warren County, Glens Falls Hospital pulled together **\$2,711,890** for the relocation and expansion!

Recently, the hospital received the required certificate from the New York State Department of Health to break ground on the project. Construction of the new 14 bed CSU, with segregated areas for adults and youth, has begun and will be completed later in 2024.

## 1897 LEGACY CIRCLE

One of the most significant ways a donor can create a lasting impact on Glens Falls Hospital is by making provisions today for future giving. Making a bequest to the hospital in a will remains the most popular way to make a planned gift. In addition, donors can designate Glens Falls Hospital as their beneficiary on life insurance policies, individual retirement accounts, donor-advised funds, and bank accounts. Other donors prefer to create lifetime income vehicles with charitable gift annuities and charitable remainder trusts, which can result in significant tax savings.

Letting the Foundation know of your intentions in advance allows us to recognize you now and starts a dialogue to ensure that we can carry out your wishes. We are always pleased to work with donors so that they can meet their philanthropic goals. We honor those donors through membership in the 1897 Legacy Circle and by recognizing them in our annual report, keeping them up to date on hospital news and inviting them to events.


