Dear Patient,

Our records indicate that you may currently be enrolled in a CDPHP insurance plan. If so, please read the important information below regarding your coverage.

Since April, the Albany Med Health System has been negotiating with CDPHP to resolve the insurance company's unfulfilled obligations to our hospitals. We have not reached an acceptable agreement.

While we remain hopeful an agreement is reached, the Albany Med Health System may be forced to remove CDPHP as an accepted insurance plan in 2025. No final decision has been made at this time, but we must inform you of the possibility that services provided by Albany Medical Center, Columbia Memorial Health, Glens Falls Hospital, and Saratoga Hospital may no longer be in-network for CDPHP members.

We understand this is an inconvenience to you and are working diligently to resolve the matter so there is no disruption to your care. However, CDPHP's 2025 contract proposal does not cover the cost of caring for its members. It also presents a significant challenge to the System's overall mission. As such, we may be in the additional position of reducing the number of services we provide.

Since a contract with CDPHP has not been finalized and no final decision has yet been made, it is important for you to consider your options. We invite you to review them on the next page or on our website, which also includes other resources for which you may be eligible, at **albanymed.org** under **Accepted Insurance**.

Please know that emergency services at Albany Med Health System hospitals always remain available regardless of your insurance.

Thank you for trusting the Albany Med Health System with your care. As the region's largest and only locally overseen health system, we remain committed to serving you.

We will be reaching out to you with updates as the situation with CDPHP unfolds.
